
ARTICLE VI

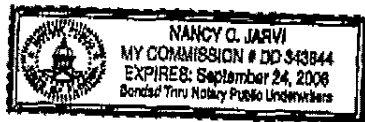
