**ARTICLE I
NAME**

The name of this limited liability company (the "Company") shall be Harvey Properties, LLC.

**ARTICLE II
DURATION**

Unless earlier terminated pursuant to the Act or any written operating agreement (as defined in Section 608.402 (24) of the Act) among the Members of this Company, the period of its duration shall be perpetual.

**ARTICLE III
ADDRESS**

The mailing address and the street address of the principal office of this Company shall be 825 Lake Ridge Drive, Tallahassee, Florida 32312.

**ARTICLE IV
REGISTERED AGENT**

The initial registered office of this Company shall be 825 Lake Ridge Drive, Tallahassee, Florida 32312, and its initial registered agent at such office shall be Charles B. Harvey, Sr.

**ARTICLE V
ADDITIONAL MEMBERS**

Pursuant to Section 608.4232, of the Act, additional members may be admitted as provided in the operating agreement, as amended from time to time.

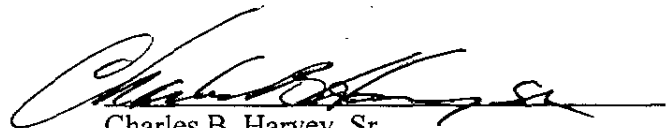
**ARTICLE VI
CONTINUATION OF BUSINESS**

Pursuant to Section 608.441(1)(d), Florida Statutes, this Company shall have the right to continue the Company's business upon the occurrence of any event that terminates this Company because there are no members.

**ARTICLE VII
MANAGEMENT OF THE COMPANY**

This Company will be managed by one or more manager(s) appointed by the members in accordance with the terms of the operating agreement. As such, the Company will be manager-managed. Such managers will be responsible for the management of the day-to-day operations of the Company. In that regard, they shall have all the powers and authority permitted under the Act, except as may be expressly provided for in the operating agreement. The initial manager shall be Charles B. Harvey, Sr.

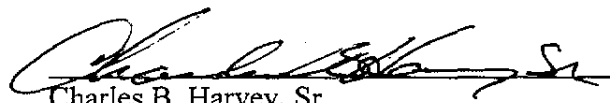
