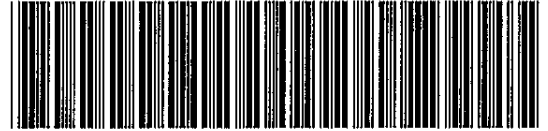

**ARTICLES OF ORGANIZATION
OF

The Company shall have perpetual existence. The Company's existence shall commence on the date and time of filing of these Articles of Organization by the Florida Department of State as evidenced by the Department of State's date and time endorsement on the original document.

ARTICLE IV. MANAGEMENT

MANAGEMENT. The Company shall be a member-managed limited liability company. The members of the Company may elect or appoint one or more members to serve as managing-members of the Company in accordance with the provisions of the Operating Agreement of the

Company. In the event that the members of the Company elect or appoint one or more members to serve as managing-members of the Company, the remaining members of the Company who were not so elected or appointed shall have no power or authority to bind the Company in any way, pledge its credit or to render it liable for any purpose unless such member has been authorized by the managing-members in writing to act as an agent of the Company in connection with such transaction.

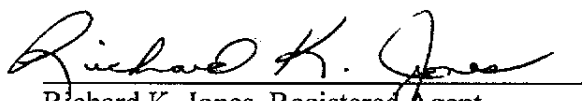
CERTIFICATE OF DESIGNATION OF
