**AMENDED & RESTATED
ARTICLES OF ORGANIZATION
OF
LAKESIDE GARDENS MOBILE HOME PARK, LLC**

THESE AMENDED & RESTATED ARTICLES OF ORGANIZATION (the "Amended & Restated Articles") of LAKESIDE GARDENS MOBILE HOME PARK, LLC, a Florida limited liability company (the "Company"), are submitted in accordance with §608.411(4) of the Florida Limited Liability Company Act (the "Act") for purposes of amending and restating the Articles of Organization of the Company in their entirety. From and after the date of filing hereof, the Amended & Restated Articles shall be as set forth in Article SECOND below.

FIRST: The information required by §608.411(4) of the Act is as follows:

- (i) The limited liability company's present name is "LAKESIDE GARDENS MOBILE HOME PARK, LLC."
- (ii) The date of filing of the Articles of Organization of the Company was February 17, 2005.
- (iii) These Amended and Restated Articles will take effect at the time and date on which they are filed with the Florida Department of State.
- (iv) These Amended & Restated Articles have been duly executed and are being filed in accordance with §608.411 of the Act.

SECOND: The Amended & Restated Articles of the Company are as follows:

**ARTICLE I
NAME**


