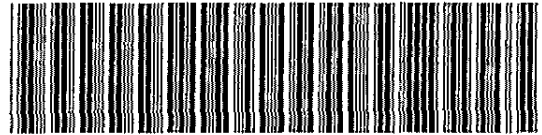

**ARTICLES OF ORGANIZATION OF  
BARKIN, LLC**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I - Name**

The name of the limited liability company (hereinafter referred to as the "Company") is "BARKIN, LLC."

**ARTICLE II - Address**

The mailing address and street address of the principal office of the Company is 125 S.W. 11<sup>th</sup> Street, Ocala, Florida 34474.

**ARTICLE III - Duration**

The Company is to be a manager-managed company. The initial Manager is designated as ARAMCO, INC.

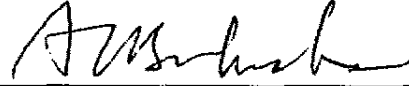
**ARTICLE VI - Limitation on Agency Authority of Members**
