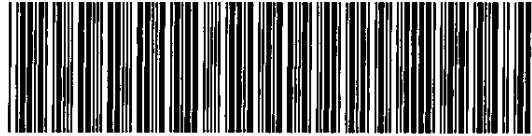

**SECOND:** This amendment is submitted to amend the following:


Nathaniel Zinno is transferring his Membership Percentage Interest on Michael A. Eshack.
