- ALL PURCHASES, SUPPLIES AND BUSINEES ITEMS TOTALING MORE THAN \$1,000 FOR ANY ONE ITEM WILL REQUIRE MAJORITY CONSENT. MAJORITY IS DEFINED AS MORE THAN 50% OF THE MANAGING MEMBERS.
