The Limited Liability Company is to be managed by the members.


**9. EFFECTIVE DATE.**

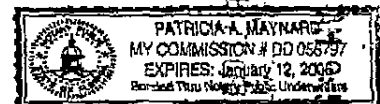


