ARTICLES OF ORGANIZATION FOR FLORIDA 2005 FEB 17 P 3: 38 LIMITED LIABILITY COMPANY

The undersigned certify that we have associated ourselves together for the purpose STATE of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following articles shall serve as the Charter and authority for the conduct of the business of the limited liability company.

ARTICLE I
