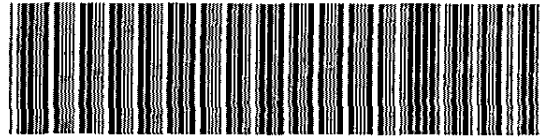



**ARTICLES OF ORGANIZATION OF
CONSOLIDATING SOLUTIONS INTERNATIONAL, LLC**

Article I

The name of the limited liability company ("Company") is CONSOLIDATING SOLUTIONS INTERNATIONAL, LLC.

Article II
