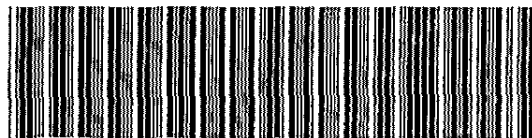

**ARTICLE 1 - NAME OF LIMITED LIABILITY COMPANY**

**ARTICLE 3 - POWERS AND GENERAL NATURE OF BUSINESS**

#### **ARTICLE 4 - LIMITED LIABILITY EXISTENCE**

This Limited Liability Company shall begin existence on the date and time when these Articles are filed with the Florida Department of State and shall exist perpetually unless dissolved according to the laws of the State of Florida, or as provided in the regulations adopted by the members.

#### **ARTICLE 5 - EXERCISE OF POWERS**

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the members of this limited liability company. This Article may be amended from time to time in the regulations of the limited liability company by a unanimous vote of the members of the limited liability company.

#### **ARTICLE 6 - MEMBERSHIP RESTRICTIONS**

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company. A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of the members. On the death, retirement,


resignation, expulsion, bankruptcy, or dissolution of a member, of the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

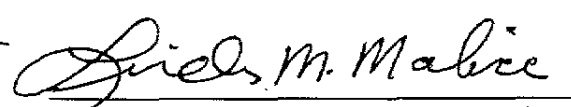

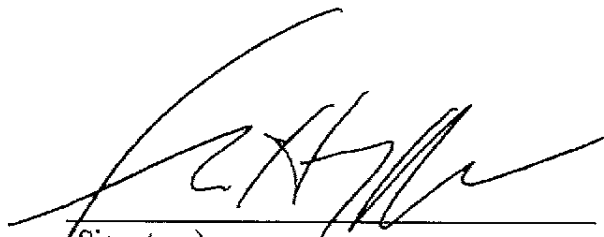
