**ARTICLES OF CORRECTION FOR
FLORIDA LIMITED LIABILITY COMPANY**

Pursuant to section 608.4115, Fla. Stat., this document is being submitted within the required thirty (30) business days to correct the attached articles of organization of PINE STREET/RPS, L.L.C., a Florida limited liability company (the "Company").

1. The name of the limited liability company as filed with the Secretary of State was: PINE STREET RPS, L.L.C.
2. The Articles of Organization for the Company contain two incorrect statements. The incorrect statements, the reasons the statements are incorrect, and the corrected statements are as follows:

FIRST CORRECTION:

Article I of the Articles of Organization incorrectly sets forth the name of the Company as "PINE STREET RPS, L.L.C." the correct Company name should be "**PINE STREET/RPS, L.L.C.**"

SECOND CORRECTION:

Article 4 of the Articles of Organization incorrectly identifies the Company as "member-managed" and identifies William M. Easton as the "managing member".

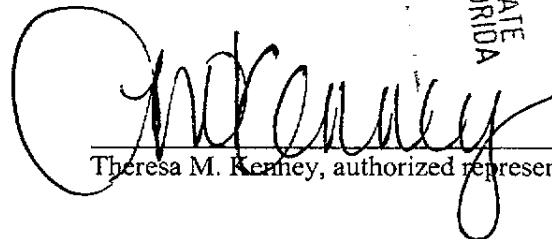
The corrected Article 4 should identify the Company as a "Manager-managed" limited liability company and identify Stanton W. Hudmon as Manager of the Company. The address of the Company is unchanged.

Accordingly, Article 4 of the Company's Articles of Organization should read as follows:

ARTICLE 4: MANAGEMENT. The Limited Liability Company is to be managed by a manager and the name and address of the initial Manager is: Stanton W. Hudmon, 1923 Southhampton Road, Jacksonville, FL 32207.

3. Except as expressly amended hereby, the Articles of Organization for the Company are hereby ratified and remain in full force and effect.

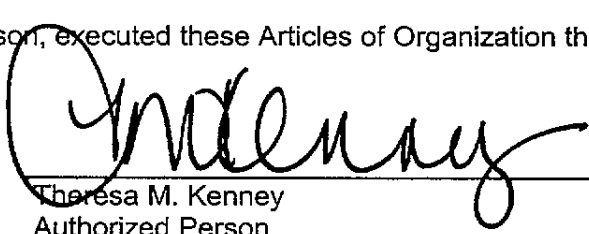
