# AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF FOCD, LLC

The undersigned, being authorized to execute and file these Amended and Restated Articles of Organization, hereby certifies as follows: Pursuant to Chapter 608, Florida Statutes, the Articles of Organization of FOCD, LLC, a Florida limited liability company (the "Company"), which were originally filed on February 22, 2005, are hereby amended and restated in their entirety.
