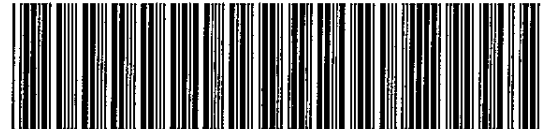

ARTICLES OF ORGANIZATION

OF

a Florida Limited Liability Company

**ARTICLE I
NAME**

The name of this Limited Liability Company is ALLEY CAT 5, LLC (the "Company").
