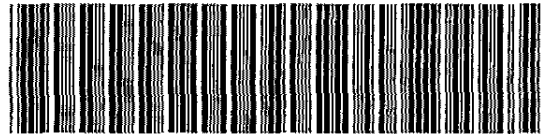

# **ARTICLES OF ORGANIZATION**

#### **ARTICLE 1 - NAME**

whose addresses shall be the same as the principal office of the Company.




