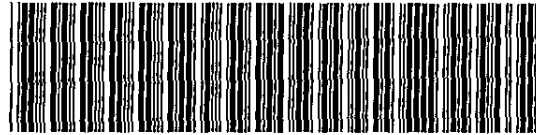

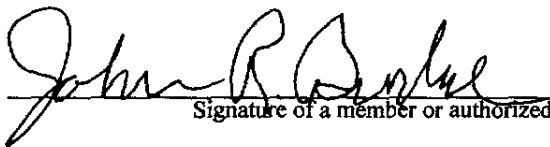
**FIRST:** The Articles of Organization were filed on 02/24/2005 and assigned document number L05000018587.
