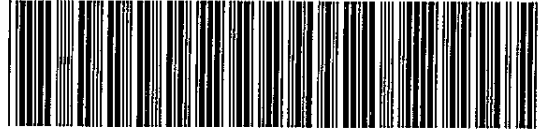

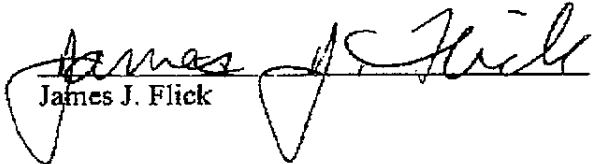
FIRST: The original Articles of Organization were filed on February 24, 2005, and assigned Document No. L05000018616.
