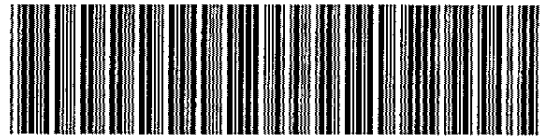

1. Upon written agreement of two-thirds of the Membership.

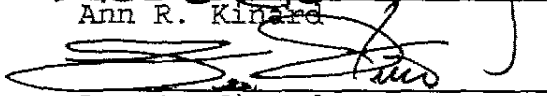

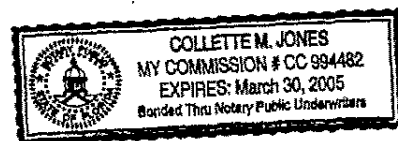
