FOR

ARTICLE 1 – Name. The name of the limited liability company shall be Dis&Dat, LLC.

ARTICLE 2 – Address of Principal Office. The mailing address and principal office of the limited liability company shall be 210 Perth Court, Winter Springs, Florida 32780.


