Articles of Organization of REDLANDS COVE DEVELOPMENT, L.L.C.

Pursuant to the Plorida Limited Liability Company Act the undersigned, acting as organizer of a limited liability company, hereby adopts the following Articles of Organization for such Company:

Article I <u>Name</u>

Article III Units Of Equity Ownership

Section B. Restrictions on Disposition of Units. Section C. <u>Limit on Number of Members</u>. All of the Company's issued units shall be held of record by not more than five persons.

Article VII Purpose And Power

The Company shall be formed for any lawful purposes and shall have unlimited power to engage in and to do any lawful act concerning any and all lawful businesses for which companies may be organized under the Florida Limited Liability Company Act. The Company shall not indemnify any Member, Manager and/or Member-Manager in the event of (i) a breach of such Member, Manager and/or Member-Manager's duty of loyalty to the Company or its Members, (ii) acts or omissions not in good faith or which involve intentional misconduct or knowing violation of the law, (iii) a transaction from which such Member, Manager and/or Member-Manager derived an improper personal benefit, or (iv) acts or omissions for which indemnification is prohibited under the Florida Limited Liability Company Act, or (1) judgments, penalties, fines, and settlements arising from any proceeding by or in the right of He Company, or against expenses in any such case where such Member, Manager and/of 255 Member-Manager shall be adjudged liable to the Company.
