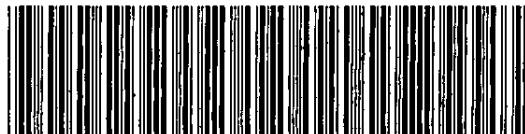

AMENDED ARTICLES OF ORGANIZATION

OF

The undersigned, being authorized to execute and file these Amended Articles on behalf of the members of Sand Dune Properties, L.L.C., for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S.
