The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **EQUINEPARTNERSHIPS.COM BARN 4, LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 12826 Northeast 25th Avenue, Anthony, Florida 32617 and the mailing address shall be the same.

whose addresses shall be the same as the principal office of the Company.

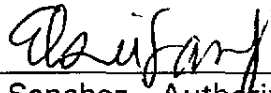

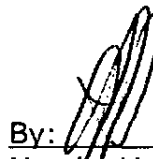
