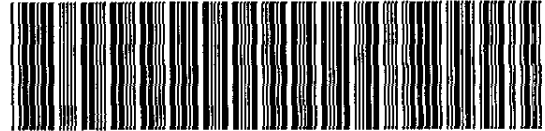

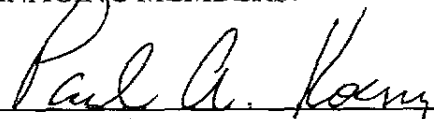
**ARTICLE VI – Members’ Rights to Continue Business:**

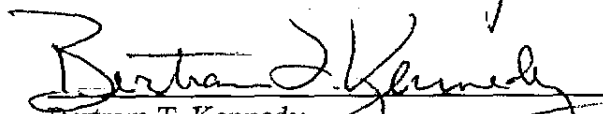
