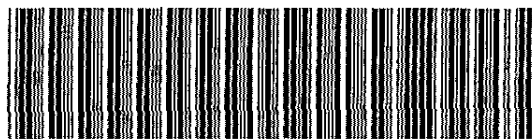

of




