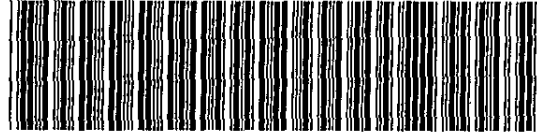

ARTICLE I – Name

The name of the limited liability company (hereinafter “Company”) is:


