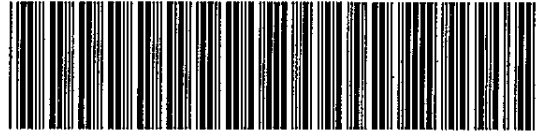



The undersigned for the purpose of forming a Limited Liability Company pursuant to Chapter 608 Florida Statutes, as amended (the "Florida Limited Liability Company Act"), hereby file the following Articles of Organization with the Secretary of the Department of State of the State of Florida, and affirm that the facts stated in these Articles of Organization are true and correct.

**ARTICLE I**

Name and Address of the Company

The name of the limited liability company is HUMITECH OF NORTHWEST FLORIDA, LLC (the "Company"). The street address of the principal office of the company is 311 Lulabelle Lane, Fort Walton Beach, Florida 32548, and the mailing address of the company is 311 Lulabelle Lane, Fort Walton Beach, Florida 32548.

**ARTICLE II**

Duration

The term of this Limited Liability Company shall be from the date of filing of these Articles of Organization with the Office of the Secretary of the Department of State of the State of Florida until the earlier to occur of the following:

(1) The date upon which a dissolution (as defined in the Florida Limited Liability Company Act) of the Company occurs pursuant to the laws of the State of Florida; or

(2) The date upon which a dissolution occurs pursuant to the terms of the Operating Agreement of the Limited Liability Company, as in effect on the date an event of dissolution occurs.

### ARTICLE III

#### Purpose

The purpose for which the Limited Liability Company is formed is to market, distribute, and sell products/technology related to the humidity control industry and all things related thereto, and to engage in any other lawful act or activity incidental thereto for which limited liability companies may be organized pursuant to the Act. The Company is not to engage in any act or activity requiring any consents or approvals by law without such consent or approval being first obtained.
