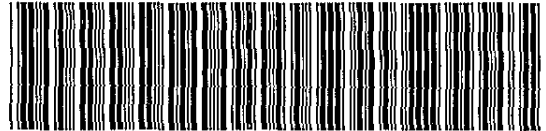

Article 1. Name

The name of the Limited Liability Company is: **NORWOOD NAPLES LLC**

Article 2. Initial Mailing Address and Principal Office

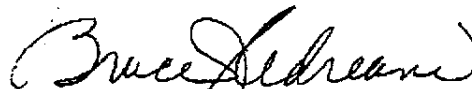
Article 7. Adoption of Operating Agreement and Regulations

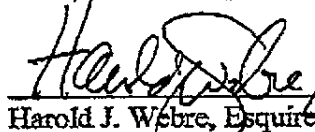
