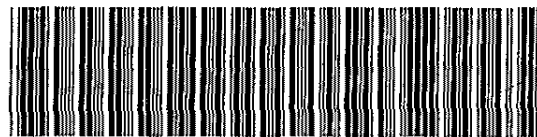

Gentlemen:

I am pleased to enclose an original and a copy of the corrected Articles of Organization and Certificate of Designation of Registered Agent/Registered Office for Direct Express Service, LLC, along with an original and one copy of an application for registration of the fictitious name of D.E.S. Please have certified copies and returned to me. No filing fees are enclosed for either the limited liability company articles of organization or for the application for registration of fictitious name for the reasons stated below.

On February 21, 2005, this office delivered to your office via Federal Express Overnight Delivery for filing an original and a copy of the Articles of Organization of Direct Service Express, LLC, along with Mr. Chadwell's check in the amount of \$155.00 for the filing fee and for a certified copy of the Articles of Organization. Also enclosed was an Application for Registration of Fictitious Name for the fictitious name of D.E.S., along with Mr. Chadwell's check in the amount of \$80.00 for the filing fee and for a certified copy of the registration.

Early the morning of February 21, 2005, we discovered that the name of the LLC had been incorrectly stated in both the Articles of Organization and the Application for Registration of

Fictitious Name. My office assistant called your office regarding the error and your staff graciously agreed to attempt to stop the LLC from being registered and either hold the papers awaiting receipt of the correct documents, or return the documents to this office.

My office assistant learned by phone call to your office today that the Articles of Organization are being returned to this office. Additionally, she learned that the \$155.00 filing fee for the limited liability company articles of organization has been deposited/cashed, and that as a result of depositing that sum, it was not necessary to include any additional fees for the enclosed articles of organization.

In regard to the enclosed application for registration of fictitious name, we are unclear as to what action may be taken by the Fictitious Name Department. We have received no definitive response to our inquiries as to whether the application for registration of fictitious name delivered to you on February 21, 2005 will be returned to us along with the \$80.00 registration fee. Therefore, out of an abundance of caution, I am including in this correspondence the new application for registration of the fictitious name of D.E.S. without any filing fee. I would ask that a copy of this letter along with the original and the copy of the new application for registration of the fictitious name of D.E.S. be forwarded to the Fictitious Name Department and that the Fictitious Name Department contact my office if there is any additional information needed or fees required in order to process the new application for registration of the fictitious name of D.E.S.

ARTICLES OF ORGANIZATION
OF
Direct Express Service, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be Direct Express Service, LLC ("company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is 3037 Red Fern Road, Cantonment, FL 32533.

ARTICLE III -- DURATION

The company shall commence its existence on the date these Articles of Organization are executed. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the operating agreement.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida is David Chadwell at 3037 Red Fern Road, Cantonment, FL 32533.

ARTICLE V -- CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company the cash or property set forth in Exhibit "A".

ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members, or as provided in the operating agreement.

ARTICLE VII -- ADMISSION OF NEW MEMBERS

Except as set forth in the operating agreement, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the operating agreement of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous vote of all the remaining members.

ARTICLE IX -- MANAGEMENT

The company shall be managed by a manager in accordance with operating agreement adopted by the members for the management of the business and affairs of the company. The operating agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 

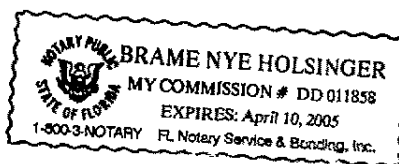
