FOR

ARTICLE 1 – Name. The name of the limited liability company shall be Dot G Productions, LLC.

ARTICLE 2 – Address of Principal Office. The mailing address and principal office of the limited liability company shall be 8740 Crestgate Circle, Orlando, Florida 32819




