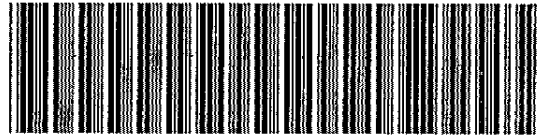

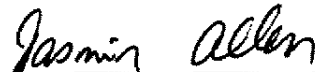
ARTICLE VIII
