**ARTICLES OF ORGANIZATION  
OF  
SKY, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (the Florida Act), Florida Statutes, Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be:

**SKY, LLC**

(hereinafter referred to as the "Company")

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Company is:

**ARTICLE III - PURPOSE AND POWER**

The business of the Company shall be to carry on any lawful business or activity in accordance with applicable law, and to have and exercise all of the powers, rights and privileges which a limited liability company organized pursuant to the Florida Act may have and exercise. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The period of duration for the Company shall be 20 years, unless the Company is sooner dissolved by the members or as provided by state law.

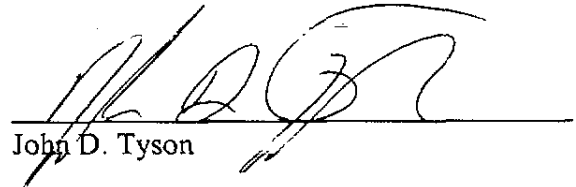
