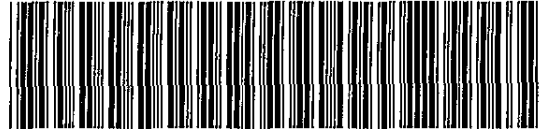

REGISTERED AGENT**




