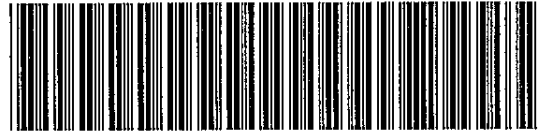

**ARTICLES OF ORGANIZATION

The undersigned individual, acting as the authorized representative of a member under the provisions of Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name

Transfer of Member's Interest

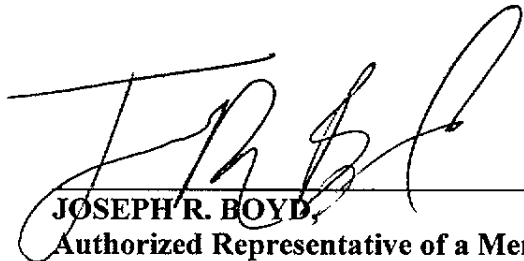
