

- 1. <u>NAME OF LIMITED COMPANY</u>. Pursuant to the requirements of Florida Statute 608.406 and 608.407(1)(a) the name of this limited liability company is AMERICAN KNIGHT INSPECTIONS, LLC.
- 2. <u>AUTHORITY FOR ORGANIZATION</u>. This organization is created under the authority of Florida Statutes 608.401-608.705, the "Florida Limited Liability Act."


