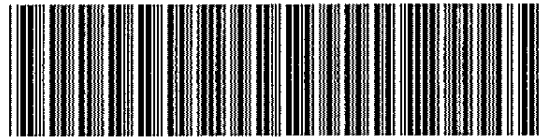




ARTICLE VI
