THIRD: The date of each amendment's adoption: April 28, 2005.

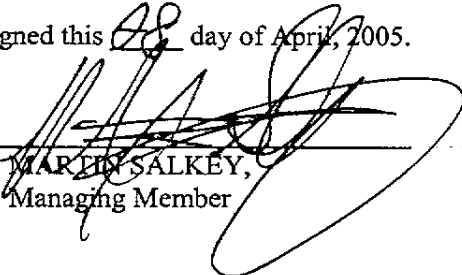
FOURTH: Adoption of Amendment(s) were by the consent of all of the members of the company.
