**ARTICLES OF ORGANIZATION
OF
COIN DEVELOPMENT I, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be COIN DEVELOPMENT I, LLC ("Company"). The principal place of business of the Company shall be 3010 South Third Street, Jacksonville Beach, Florida 32250. **ARTICLE II
DURATION**

The Company shall commence its existence on the date these Articles of Organization are executed. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

**ARTICLE III
PURPOSES AND POWERS**

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

Members shall have the right to admit new members only by unanimous consent of the membership and Managers. Contributions of new members shall be determined as of the time of admission to the Company.

A member's interest in the Company may not be sold or otherwise transferred, except as provided in the written Operating Agreement of the Company.

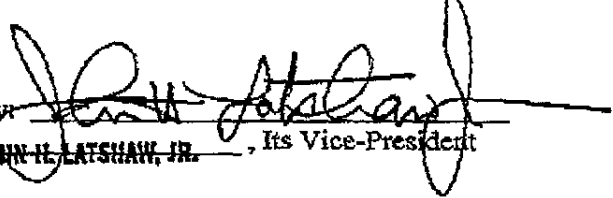
