AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF COIN DEVELOPMENT I, LLC

The undersigned, having filed on March 1, 2005 the original articles of organization of COIN DEVELOPMENT I, LLC, a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Amended and Restated Articles of Organization.

ARTICLE I NAME

These Amended and Restated Articles of Organization Articles shall cancel and supersede the original Articles Of Organization filed with the Florida Secretary Of State, Division of Corporations.
