The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

# ARTICLE I - NAME

The name of the limited liability company shall be SOLARSTAR, LLC, a limited liability company (the "Company").

# ARTICLE V -- CAPITAL CONTRIBUTIONS
