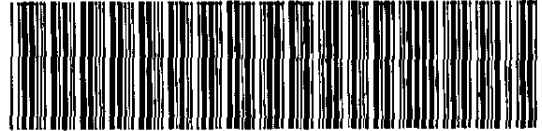

**ARTICLES OF ORGANIZATION OF

Registered Agent and Office


The initial registered agent for this Company shall be Darian W. Johnson, 11300 Fourth Street North, Suite 200, St. Petersburg, FL 33716.

The undersigned has executed these Articles of Organization this 11 day of FEBRUARY, 2005.




