ARTICLES OF ORGANIZATION OF CINNAMON ROLL INVESTMENTS, L.L.C.

The undersigned hereby certify that we have associated ourselves together for the purpose of becoming a Limited Liability Company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liabilities companies for profit. We further declare that the following articles shall be the charter and authority of the conduct of business of such limited liability company.

ARTICLE I

NAME

The name of the limited liability company shall be Cinnamon Roll Investments, L.L.C., and its principal place and of business and mailing address shall be at 570 Woodland Bayou Drive, Santa Rosa Beach, FL 32459, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

ARTICLE IV

PROFITS AND LOSSES

(a) Sharing of Profits. The members shall be entitled to the net profits

arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company.

Each member shall be entitled to the distributed share of the profits specified in accordance with the percentage of membership interests that each member owns related to the total membership interests outstanding.

(b) Losses. All losses that occur in the operation of the limited liability company business and the profits of the business, or, if such sources are insufficient to cover such losses, by the members in accordance with the percentage of membership interests that each member owns related to the total membership interests outstanding.

ARTICLE V

LIMITED LIABILITY COMPANY POWERS

ARTICLE VII

PRINCIPAL PLACE OF BUSINESS

ARTICLE VIII

MANAGEMENT

- A. This limited liability company shall be managed by the managing members; however, all of the following shall require a fifty-one percent (51%) votes from the members:
 - a. assigning property to creditors or other assignees;
 - b. confessing a judgment;
 - c. submitting a claim to arbitration;
 - d. executing and delivering any debt instruments;

- e. conveying real or personal property of Cinnamon Roll Investments,

 L.L.C.;
- f. pledging a member's membership interests to individuals or entities outside of Cinnamon Roll Investments, L.L.C.;
- g. disposing of the goodwill of the company.

A member interests in the limited liability company may not be sold or otherwise transferred except with a fifty-one percent (51%) vote of the then existing members.
