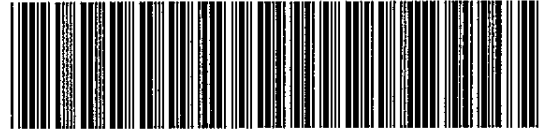

**ARTICLES OF ORGANIZATION
PRESTIGE AUDIO VIDEO SOLUTIONS
L. L.C.**

The undersigned adopt the following Articles of Organization for the purpose of becoming a limited liability company under the Florida Limited Liability Company Act:

**ARTICLE I
Name**

The name of the limited liability company, referred to in these Articles as "Company" is PRESTIGE AUDIO VIDEO SOLUTIONS, L.L.C.

**ARTICLE II
Duration**

The company shall dissolve on December 31, 2034.

**ARTICLE III
Purpose**

The purpose for which Company is organized is to sell and install home video systems, as well as to transact any or all lawful business for which limited liability companies may be organized under the Florida Limited Liability Company Act.

**ARTICLE IV

The remaining members of the company may continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company.

ARTICLE X
Additional Provisions

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the managers listed in Article VII.

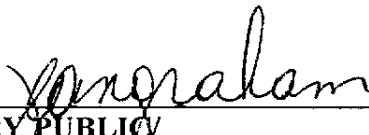

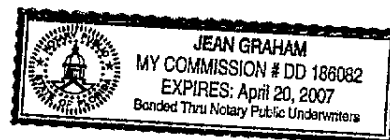

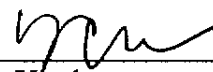
