The undersigned person, acting as the organizer of Big Three Investors, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited company is:

BIG THREE INVESTORS, LLC

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company will commence on the date these Articles of Organization are filed with the Florida Department of State, and the existence of the company shall be perpetual.

ARTICLE II - PURPOSE

The company may transact any or all lawful business for which a limited liability company may be organized under the Florida Limited Liability Company Act.

ARTICLE IV - INITIAL REGISTERED AGENT AND OFFICE

The street address of the initial registered office of the company is 526 East Park Ave., Suite 200, Tallahassee, Florida 32301, and the name of the company's initial registered agent at that address is UCC Filing & Search Services, Inc.

ARTICLE V - PLACE OF BUSINESS

The mailing address and the street address of the principal office of the company is Two Woodland Drive, Dallas, Pennsylvania 18612.

ARTICLE VI - ADMISSION OF THE ADDITIONAL MEMBERS

The right of the members to admit additional members and the terms and conditions of the admission shall be restricted solely to those members approved by the written consent of those members owning a majority of the membership interests of the company and upon such terms and conditions as shall be set forth in its regulations.

ARTICLE VII - REGULATIONS

The power to adopt, alter, amend, or repeal the regulations of the company is vested exclusively in the members of the company.

ARTICLE VIII - TERMINATION OF A MEMBERSHIP INTEREST

The company shall not be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the company.
