FOR

ARTICLE 1 – Name. The name of the limited liability company shall be Pura Cepa, LLC.

ARTICLE 2 – Address of Principal Office. The mailing address and principal office of the limited liability company shall be 9217 Venezia Plantation Drive, Orlando, Florida 32829.


