**ARTICLES OF ORGANIZATION
FOR
CONEXION DISTRIBUTORS, LLC**

ARTICLE 1 - Name. The name of the limited liability company shall be Conexion Distributors, LLC.

ARTICLE 2 - Address of Principal Office. The mailing address and principal office of the limited liability company shall be 9217 Venezia Plantation Drive, Orlando, Florida 32829.




