**ARTICLES OF ORGANIZATION  
OF

**ARTICLE I - NAME**

The name of this Limited Liability Company is GOODWIN INVESTORS, LLC (the "Company").

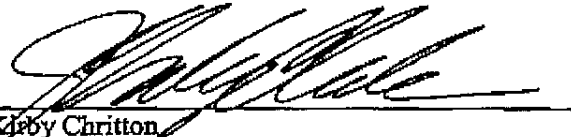

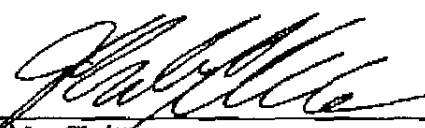
