Articles of Organization

of

B & M Equipment, LLC

Pursuant to the Florida Limited Liability Company Act the undersigned, acting as organizers of a limited liability company, hereby adopt the following Articles of Organization for such Company:

Article I <u>Name</u>

The name of the limited liability company is B & M Equipment, LLC.

Article II Company Existence

The Company's existence shall be perpetual and shall be effective upon the filing of these Articles of Organization with the Florida Department of State.

Article III Units Of Equity Ownership

Section A. Authorized Units of Equity Ownership. The maximum number of units of equity ownership units B & M Equipment, LLC is authorized to have outstanding is 1,000 units, all of which shall be identical units.

Section B. First Lien. The Company shall have a first lien upon thoughts of any Member for any debt or liability owing by such Member to the Company.

Section C. Restrictions on Disposition of Units. No Member of this Company shall sell, transfer, convey, pledge, give, distribute or encumber any unit or units in the Company without first giving notice in writing to the Company of such intended disposition and without first securing the written approval of Members of the Company owning 100% of the them issued and outstanding Membership Units of the Company. 

Article IX Indemnification
