ARTICLES OF ORGANIZATION OF PROPERTIES OF LAKE HATCHINEHA, LLC ARTICLE I - NAME

The name of this Limited Liability Company is PROPERTIES OF LAKE HATCHINEHA, LLC.

ARTICLE II - ADDRESS AND PRINCIPAL PLACE OF BUSINESS
