ARTICLES OF ORGANIZATION
OF
THIRD AVENUE NORTH, LLC

The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the Limited Liability Company ("Company") shall be Third Avenue North, LLC.

ARTICLE VII. MANAGEMENT
