Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:


1. The name of the limited liability company is Kedar, LLC (the "**LLC**").

4. Article V of the Articles of Organization of Kedar, LLC, a Florida limited liability company, is hereby added to read as follows:


Article V


